A. B. Covenant not to sue and Waiver of Subrogation: I further agree that I will never sue Snag Proof, Angler's Press for damages on account of any injury or damage I suffer or cause whether known now or which may develop in the future. I further understand that by signing this agreement I waive any rights my heirs or relatives have or may have to sue Snag Proof or Angler's Press for liability.

D. Truth Verification: Polygraph or truth verification may be given at any time at the discretion of the officers of Snag Proof or Angler's Press. Refusal or failure of polygraph or truth verification will automatically eliminate team members' participation from all future Snag Proof events.

E. Camera Release: I hereby grant Snag Proof, Angler's Press the unconditional rights to use my voice, photographic likeness and biographical information and fishing tips and instructions in connection with all Snag Proof, Angler's Press video/audio production, promotions and/or other compensation in connection with such use.

F. I signify by my signature that I have read, understand and agree to abide by all rules and regulations and decisions set forth by Snag Proof, Angler's Press tournament officials.
